HIGHLIGHTS:

- Most of the traffic (54.7%) is because we have included a DIRECT link in some emailing campaign.
- The second source of traffic (21.3%) is due to Internet positioning (ORGANIC SEARCH). SOCIAL networks are an interesting source of traffic (17.5%), especially LinkedIn and Facebook (with 453 and 201 sessions respectively).

LINKEDIN


The number of followers has increased by 390% to 460. The web traffic provided by this website has been 453 sessions, a similar number to the number of followers.

FACEBOOK

The current number of followers on Facebook is 104, which represents a growth of 142% over the number of followers in 2021. Surprisingly, the traffic brought by this social network, which is 201 sessions, doubles the number of followers.

TWITTER

Although we have a large number of followers, 878, their increase has been low (5%) and they bring little traffic to the website: only 47 sessions.

The advantages of using a corporate address are mainly twofold:

- 1.- **Reputation**. A more professional image is offered to interlocutors than a HOTMAIL or GMAIL address.
- 2.- Continuity. If the person in charge changes, the email account can be used by another person, keeping all the history and documents.


